Usually you can organise the sale through your lender, which will mean the lender will receive the money directly from your buyer during the sale. If your loan is a secured car loan, you may also be able to substitute the car you are selling with your new car as security. Check your contract and contact your lender to request a pay-out figure. If there is a dispute with your lender, you can contact the Australian Financial Complaints Authority (AFCA) for assistance. Ready for sale Prepare your car for sale by giving it a good wash and polish, and repair any minor cracks or dents in the paintwork. It is also a good idea to check the car's lights, wipers and air-conditioning are in good working order and repair them if necessary. List it for sale Before you list your car for sale, do some research to find out the selling price of similar cars to help you set a realistic price of sale. Options to sell a car include online car sites and other online selling platforms, social media, newspaper ads and notice boards. Be clear in communicating the details and condition of the car with potential buyers. You may be held liable if you are aware of a serious defect and don't make it known to the buyer. When selling a car online, be aware of scammers who may fake a payment or promise to pay you after the car is in their possession. Make sure the money has transferred before handing over the keys to the vehicle.
